Hari Setiadi is a Petroleum Engineer with over 34 years of experience in reservoir, production, operations, well intervention and well integrity. He holds Petroleum Engineering Degree from UPN Veteran Yogyakarta and MBA degree from Prasetya Mulya Business School, Jakarta.

Hari began his career in ARCO Indonesia (ARII) in 1984 served as Petroleum Engineer; followed by 16 years at ARII and hold numerous of position notably Reservoir Engineer, Petroleum Engineer, Senior Operations Engineer, District Petroleum Engineers that responsible for more than 400 wells in Offshore North West Java (ONWJ), Chief Reservoir Operations group and Corporate

Planning Analyst.

When BP took over ARCO, he worked as CT and SIMOPS coordinator in ONWJ area. Not long after that, he holds a position as Java Well Services Manager. Furthermore, over the course of his career, in 2005 he had been entrusted to hold some positions such as Well Operations Lead, Petroleum Engineering Lead at Wytch Farm, Dorset, BP UK and Senior Petroleum Engineer at Claire Field, Aberdeen, BP UK.

Hari went back to Indonesia in 2009 and served as Asia Pacific Well Intervention and Integrity Manager at BP Asia Pacific that accountable to ensure the well integrity of 14 big bore gas wells in Tangguh Field (each well is able to produce around 200-220 MMSCF/day).

Hari is also a member of BP Global Well Integrity Team who represented Asia-pacific Region in developing BP Global Well Integrity Management System (WIMS).

In early 2016, he found PT. Well Integrity Indonesia (PT WII), a consultancy company that focused in all aspects of Well Integrity and he currently serves as President Director. His desire to improve Well Integrity conditions in Indonesia has been carried out by presenting “the Role of Well Integrity in Oil and Gas Upstream Business in Indonesia” to the GoI and as a result, he led the team that appointed by Migas to develop Standar Nasional Indonesia (SNI/Indonesian National Standard) for Well Integrity.
